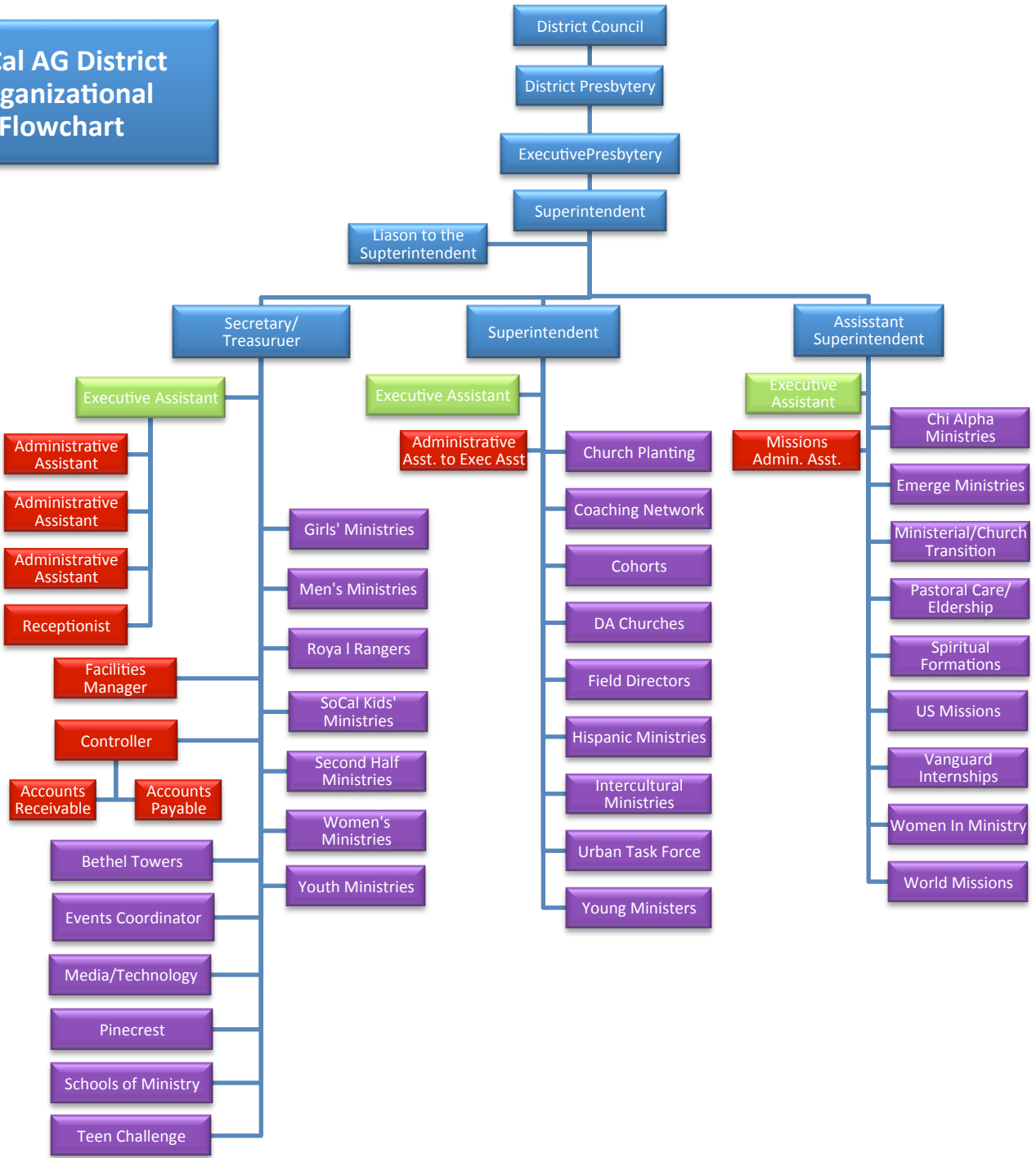


# SoCal AG District Organizational Flowchart

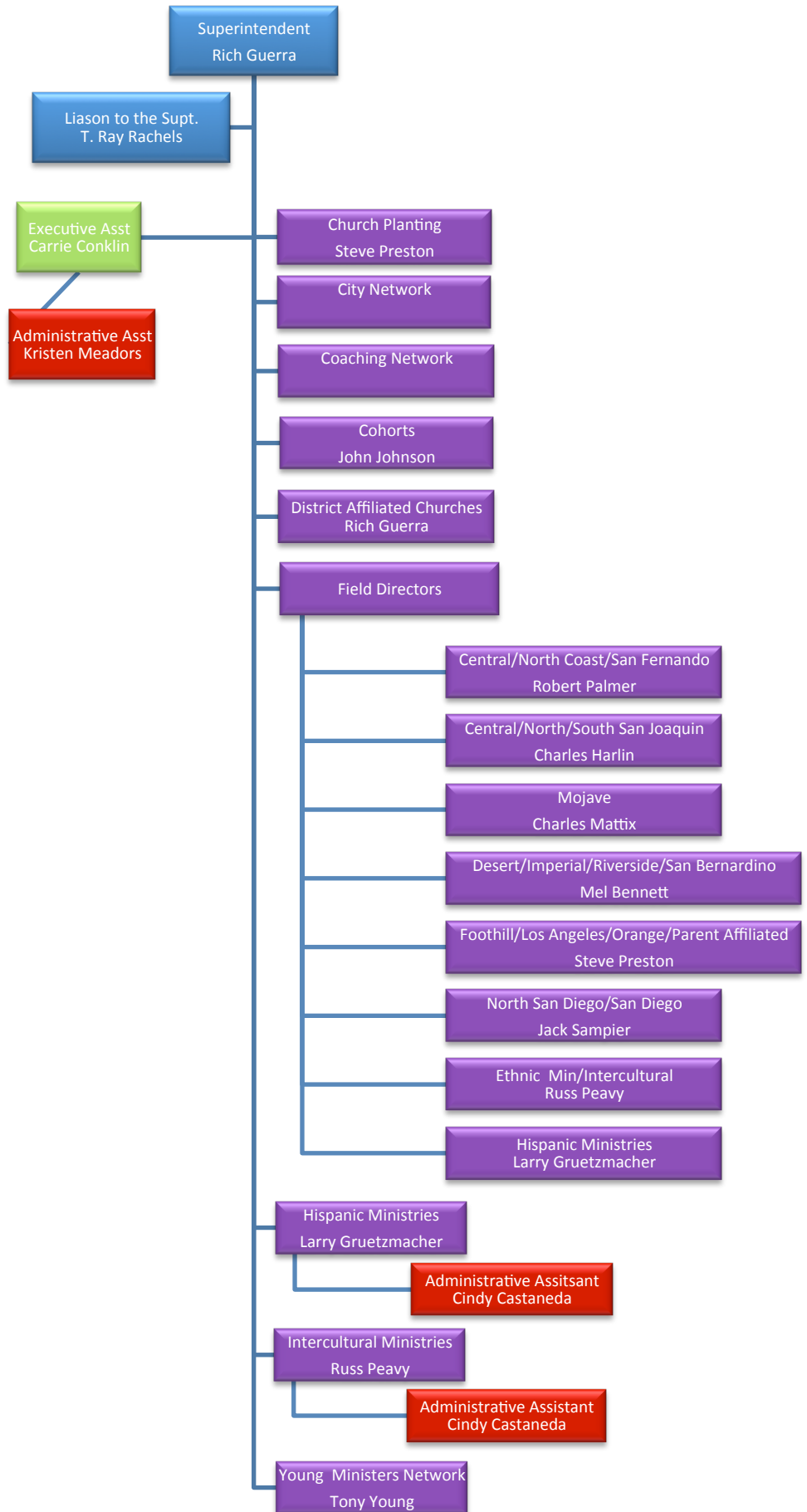

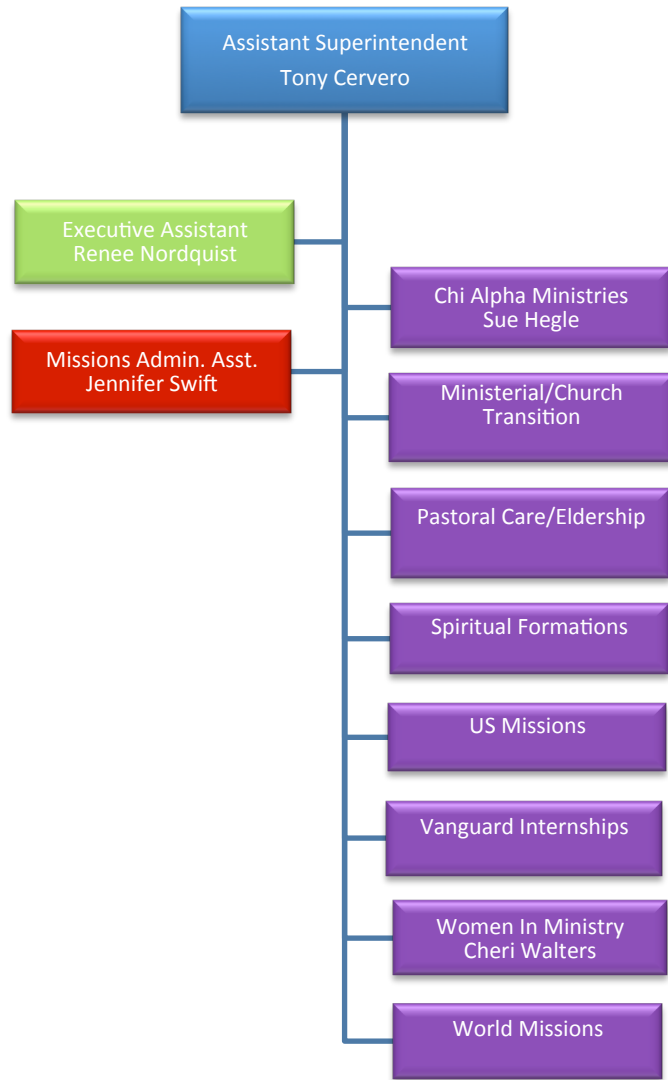
